Born and raised in Miami, Saline County, Missouri. Graduated Magna Cum Laude from Missouri Valley College, and later from the University of Michigan with a Masters Degree in business management; did graduate work at Harvard. Served for twenty-eight years in the U. S. Navy, including service in WW II, Korea, and Viet-Nam; retired as a Captain. Very active in community service in his hometown of Miami, which included obtaining funds to build the Miami Community Center. Inducted into the Missouri Valley College sports Hall of Fame in basketball. He was an avid hunter and fisherman, and was a published author. Died in St. Mary's Hospital, Tucson, Pima County, Arizona; per his request his body was returned to Miami for burial next to his first wife.

Educated in rural schools, and started training as a physician prior to the Civil War. In 1862 Amos left school to join the Missouri State Militia, and served near his home for one year. In 1863 he transferred to the Ninth Missouri Regiment of Cavalry, United States Army, and fought with that unit until someone discovered that he had been educated as a doctor; sent to work in hospital until he was discharged. Reportedly fought at Mitchell, Lexington, and Fayette under Colonel Oden Guitar. Left military service in 1865, and returned to Saline County where he practiced medicine for five years. Enrolled at the University of Iowa, Keokuk, in 1870 in order to complete his formal education. In 1871 he returned home and practiced until 1883, when he enrolled at the College of Physicians & Surgeons in St. Louis, Missouri. Following graduation in 1884 he practiced medicine in and around Saline County, Missouri. In 1907 a local newspaper reported that he had a complete daily record of the local weather since the year 1840 (started by a neighbor, Jesse J. Ferrill). At the beginning of WWI he joined the Army Medical Reserve Corps, and served overseas until the armistice. Member of the Cumberland Presbyterian Church. Republican. Mason. Oddfellow. Owned 3000+ acres in Saline County. He never recorded a will. His unique middle name, Weeden, is believed to be taken from Henry J. Weeden, a Justice of the Peace in Saline County who shared legal duties with Amos' father, also a JP. Living in Miami, Saline County, Missouri, at the time of his father's death. His collected papers and record books are included in the Western Historical Manuscript Collection at the University of Missouri, Columbia, under the name Amos H. Sullivan.

Notes for Samuel Wells Sullivan, Jr.:

Brought as a child, in 1827, to the Harmony Community, some six miles east of Miami, Saline County, Missouri. Served in a reserve unit of the Union Army during the Civil War. Held the office of Justice of the Peace for many years, and performed the marriages for a number of his family members. Had a total of thirteen children, six of whom were still alive in 1893. Inherited his father's entire estate at the time of the elder ("Old Sam") Sullivan's death, and further developed the lands until he was one of the wealthiest land owners in Saline County. Most of his brothers and sisters lived on land which their father had "given" them when they got married. Rather than sharing his inheritance, Samuel notified his siblings they would be required to pay rent if they intended to continue living there; also required each family to provide him with a certain percentage of their farm products each year. Anyone finding themselves at odds with him were required to leave their homes, and were prohibited from being buried in the family plot at Harmony Cemetery. Contemporary records suggest he was a kind and generous man to the people who were in his favour, but could be cold and ruthless to anyone who disagreed with him, family or not. His brief obituary lists him as "Samuel Weeden Sullivan".

Worked primarily as a farmer. Lived in and around Miami, Saline County, Missouri for most of his adult life. Served in Company "H", 9th Missouri State Militia Cavalry, United States Army during the Civil War. Family history suggests that during his military service he became depressed about being away from his wife and, in an attempt to be discharged early, shot himself in the foot with a pistol. Although his military service is well documented it is also documented that both he and his wife were later denied a military pension, the reason given being his "actions" during the war. (One of Benjamin's descendants seems to have taken affront to any such suggestion, and has actively campaigned fellow Sullivan

researchers to remove any and all references to the event from their records.) Benjamin's headstone is standard military issue, and indicates his name and Civil War unit. His obituary was printed in the SLATER NEWS RUSTLER on Friday, 24 April 1931. Died from pneumonia during an influenza outbreak. Member of the Harmony Presbyterian Church, serving as a deacon, for sixty years.

Notes for Samuel J. Sullivan:
Dependable information about Samuel has been rather difficult to obtain. Most of what we do know about he and his family comes from his obituary, and from contemporary notes that his descendants donated to the Marshall, Saline County, Missouri, library. (There has always been a good bit of traditional history available, but representatives from Samuel's various family lines just can't agree upon the validity of this data.) His obituary states that he was only married twice, and died at age 49, but additional civil records indicate that he was married to at least four ladies and possibly to as many as six, and that he was born in 1854. Most, if not all, of his proposed wives were still alive at the time of his

death. (Did his patriarchal father, as local Justice-of-the-Peace, intervene on Samuel's behalf to "correct" matters when his relationships went sour?) While most family reports suggest Samuel spent all of his adult life working as a farmer in/around Saline County, Missouri, the 1880 census for Delaware, Leavenworth County, Kansas, shows he, Mary, and baby Thomas living together in that community; no mention is made of their other children, and at least Perry is known to have been alive at that time.

Moved from Lancaster County, Pennsylvania, to Rockingham County, Virginia, following his military service in the War of 1812. The single-L variation of the surname is found for "Old Sam's" family in census records from Saline County, Missouri, in 1830 and 1840; changed to "Sullivan" by 1850. Served in the Virginia Militia, 5th Regiment, during the War of 1812. Worked for Miller's Ironworks, Augusta County, Virginia as a laborer; lived in the Mossy Creek Valley area of Virginia. Moved his family by covered wagon and riverboat to the Harmony Community, six miles east of Miami, Saline County, Missouri, in 1827. One report lists him as a farmer; as a carpenter in another. Presbyterian by religion, Whig by politics. "Old Sam" and his wife raised two orphans, James and John Cheton, in Saline County. Family history has always suggested that his family split allegiances during the Civil War, with three of his sons supporting the Confederacy, while two others served the Union. However, records in the National Archives

indicate that all of his sons, except Charles who was in California, served the Union in one military organization or another. He and his wife originally owned the property that became Harmony Cemetery, and were supposedly among the first individuals buried there. No headstone for either of them has been found at Harmony, and other researchers have suggested that "Old Sam" and his wife were buried together, and anonymously, on a secluded section of their family farm.

Notes for Timothy Tempest Sullivan:

While Timothy's place in this particular family has yet to be proven beyond a doubt, all of the currently available evidence supports his being "Old Sam's" father. About 1740 Timothy's family, covertly supported by Catholic Spain, took part in an unsuccessful attempt to overthrow the Protestant government of Great Britain. The remaining O'Sullivan men were either summarily executed by the English, or were forced to flee their family estates in County Cork, Ireland, for Europe or the Americas. About 1746 Timothy's family entered the American colonies through the port of Boston, and immediately divided into two distinct groups; one group moved to New Hampshire, and the other to Lancaster County, Pennsylvania. Timothy married a "Good German girl" (Pennsylvania-Dutch), and began to raise a large family of his own. In 1770 he was executor of his fathers' will in Lancaster County, and was listed as "Timothy Sullivan" on the 1771 Lancaster County, Pennsylvania tax list. Timothy joined the 3rd Pennsylvania Infantry Regiment as a Private in 1775, and fought throughout the Revolutionary War. According to family history he had four brothers who enlisted with him, and also fought during that war. Timothy and his wife reportedly produced ten sons, and an unknown number of daughters. He was found in records from Rockingham County, Virginia by 1820, and may have been in Augusta County, Virginia shortly thereafter. Timothy's occupation in Lancaster County was listed as a "Tuboc" (tobacconist) on census reports.

Notes for Cornelius O'Sullivan:

Cornelius O'Sullivan's place in this family is currently based primarily upon conjecture, and is the subject of ongoing research. Cornelius and his family were members of the Irish aristocracy, and devout followers of the Church of Rome. About 1740 Irish Catholics, covertly supported by the Spanish government, initiated an armed rebellion against Protestant England in a futile attempt to return the exiled Catholic monarch, Bonnie Prince Charlie, to the English throne. Following the Protestant victory in 1745, the few surviving male members of the O'Sullivan nobility were either executed by the British or fled to Europe or the Americas. Cornelius was known to have survived the insurrection, and traveled from Ireland to France by ship. Shortly after arriving in France, Cornelius and other members of the combined O'Sullivan family boarded a ship bound for the American colonies. Early documentation shows that a Cornelius O'Sullivan/Sullivan arrived with his family at the Port of Boston about 1746, and immediately moved to the Pennsylvania-Dutch (German) settlements. Lancaster County, Pennsylvania, was one of the few areas in the colonies not under the direct control of Britain, and was a haven for Irish and German refugees who had a mutual dislike/distrust for the English. It is believed that Cornelius, like his nephew Master John (Owen) Sullivan (father of Revolutionary War General, John Sullivan), changed his surname after he arrived in America and reluctantly began to acknowledge, if not exactly follow, the Protestant faith, in order that his family might achieve greater acceptance. A last will and testament for Cornelius Sullivan was filed on 25 May 1769 in Lancaster Borough, Lancaster County, Pennsylvania, and probated on 02 January 1770; the executor was Cornelius' son, Timothy Sullivan. It is believed that the son, Timothy, is the same Timothy Sullivan found on the 1771 Lancaster Borough, Pennsylvania tax list, the same individual who fought with a Pennsylvania infantry regiment as a Sergeant during the Revolutionary War, and the same Timothy Sullivan who is later found in the civil records of Augusta and Rockingham Counties, Virginia. All of the dates and places associated with Timothy Sullivan are consistent with the family history of his proposed son, Samuel Wells Sullivan, Sr.

Originally from Ardea, parish of Thouougsisty, County Kerry, Ireland. Descending from a long line of Irish nobles he held the title of Major, ostensibly in the army of Charles Edward Stuart ("Bonnie Prince

Charlie"). Following the Protestant defeat (led by William of Orange) of the Catholics, the supporters of Prince Charles were summarily arrested, and many of them were executed for treason. Those who were able to escape made their way to France, or to the English colonies in America. Major O'Sullivan took his family to France where, a short while later, he was challenged to a duel of honor. Fighting with swords he killed his opponent, but was then attacked from behind by a member of the dead man's family who "Ran him through from back to front". Philip survived the initial injury, but died from infection (an "Ulcer to his breast") several days later. His remaining family obtained passage from France to America, arriving, according to tradition, at the Port of Boston. It is believed that one "group" (the number of individuals is not known) went directly to Virginia and then on to New Hampshire, while the other traveled first to Pennsylvania and then to Virginia.

Reportedly the oldest of three brothers. Referred to as "Colonel Florence McCarthy"; fought for the Catholics against the Protestant "Orange". Known by the title "Mac Finnin".
